### **Explanation:**

The phrase serves to highlight the content of the second paragraph, which is focused on the struggles of the Neapolitan people. A is off-base as the purpose of the essay is to inform, not to persuade or to generate sympathy. B is incorrect because of the word "detail" – it is the second paragraph that provides all the detail related to the struggle. C is incorrect in that the struggle of the Neapolitan people is only half of the thesis. The other half is the fact that their culture, specifically their food, remained a part of the people's lives outside of Naples.

E. is incorrect because the phrase does not contrast the first part of the sentence; it acts as a logical extension of the first part.
