You can choose from four possible actions to include in a graphical business rule: Aggregate Data, Copy Data, Clear Data, and Create Blocks.

Note:

- * Aggregate Data —Use to calculate your database by specifying which dimensions to calculate and what calculation options you want to use during the aggregation.
- * Copy Data—Use to copy data from one part of your database to another. You select the sourcedata to copy and then specify the target or destination value.
- * Clear Data—Use to define a subset of data that will be cleared from the database before a newvalue is added. You can choose either to clear cells or to clear blocks of data.
- * Create Blocks—Use to specify a data slice to ensure that blocks are created for all sparsemember combinations in that slice.

Explanation:

Administrators use Smart Lists to create custom drop-down lists that users access from data form cells. When clicking into cells whose members are associated with a Smart List (as a member property), users select items from drop-down lists instead of entering data. Users cannot type in cells that contain Smart Lists. Smart Lists display in cells as down arrows that expand when users click into the cells.

A: To develop a calculation script that exports a subset of data, you first specify the SET

DATAEXPORTOPTIONS command to define options for export content, format, and process Use FIX...ENDFIX or EXCLUDE...ENDEXCLUDE calculations to select a slice of the database and use a DATAEXPORTCOND command to select data based on data values.

Note: The DATAEXPORT command enables calculation scripts to export data in binary or text, or directly to a relational database. A set of data-export-related calculation commands qualify what data to export and provide various output and formatting options.

Compared to using other methods to export data, using a calculation script has the following advantages and disadvantages:

Advantages:

Enables exporting a subset of data.

* Supports multiple targets: flat files, relational databases, and binary files (not B, C, D)* Provides many flexible options for type and format or data.

- * As part of a calculation script, can be easily deployed in a batch process.
- * Can be very fast when the dynamic calculation export option is not used because

DATAEXPORT directly accesses Kernel storage blocks in memory. (E)

* Provides, through binary export-import, a faster way to back up and restore data because thecompressed format used by binary export requires less storage for the export files. * Can be used as a debug tool to trace batch calculation results by using the DATAEXPORT command before and after other calculation commands to track data changes.

Disadvantages

Contains limited data formatting options compared to Report Writer formatting.

Grid spread allocates data across the cells on the webform and runs on the client browser. Mass allocate triggers a calc script which can allocate data beyond cells those are available in the form.

If your administrator has enabled Grid Spread as a data form property, you can specify an amount or percentage by which Planning increases or decreases values across multiple dimensions on the data form, based on the existing values in the target cells. You immediately see the result in the data form and can save the new data or discard it. When calculating the spread data, Planning ignores read-only and locked cells and cells having supporting detail. Data integrity is ensured by spreading values only to cells to which you have access.

If you have the Mass Allocate role (assigned in Oracle's Hyperion® Shared Services) and an administrator has enabled Mass Allocate as the data form property, you can spread data using the powerful feature, Mass Allocate, which:
